

CHL OCTOBER CONTEST

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

The “CHL October Contest” (“The Contest”) is a contest which allows participants to enter for a chance to win one of the offered prizes, pursuant to these official rules (the “Official Rules”), which are available online at (contests.chl.ca/october). The sponsor of this contest is the Canadian Hockey League (CHL) (the “Sponsor”). Any questions relating to the Contest can be directed at: support@chl.ca, 5401 Eglinton Avenue West, Suite 202, Etobicoke, Ontario, Canada, M9C 5K6. By taking part in this Contest you accept and agree to be bound by these Official Rules and agree that all decisions of the CHL (as defined below) are final and binding. The Contest is subject to all applicable federal, provincial and local laws and regulations and is void where prohibited by law. These Official Rules apply only to this Contest and not to any other promotions, contests, or sweepstakes by the CHL.

CONTEST PERIOD:

The Contest begins on October 23rd, 2024 at 10:00:00 AM ET and ends on October 30th, 2024 at 11:59:59 PM ET (the “Contest Period”).

ELIGIBILITY, RESIDENCY AND AGE:

The Contest is only open to legal residents of Canada, who are at least eighteen (18) years of age at the time of entry (each, an “Entrant”). Employees, officers and directors, and the household and immediate family members and/or those with whom such employees, officers and directors are domiciled, of the Canadian Hockey League (the “CHL”), CHL member teams, prize suppliers, and advertising/promotion agencies and their respective parent companies, subsidiaries, affiliates (collectively, “CHL Entities”) are not eligible to enter or win. For the purpose of these Official Rules, “household members” means those people who share the same residence and/or mailing address at least three months per year with one or more CHL Entities and “immediate family members” means any parent, spouse, sibling or child and their respective spouses. Sponsor reserves the right to verify the eligibility of the winner.

HOW TO ENTER:

During the Contest Period, there will be one (1) way to receive entries to the Contest via official contest pages.

1. Participants can enter via the Online contest page (contests.chl.ca/october). To successfully enter, participants must fully complete the Contest entry form available on the contest page.

Entries must be fully completed with all of the required information and received by 11:59:59 PM ET on October 30th, 2024, to be eligible.

Limit one (1) Entry per person and per email address via the Online Contest Page. The maximum number of Entries by an individual would be one (1) Entries. Additional Entries received from any one person or email address thereafter will be void.

Entries by any means, which subvert the Entry process, will be void. Releasees (as defined below) are not responsible for lost, incomplete, illegible, late, misdirected, stolen, undelivered, damaged, garbled, or mutilated Entries; lost Entries or transmissions; any error, omission, interruption, defect or delay in transmission, interrupted or unavailable network, cable, satellite, Internet Service Provider (ISP), server or other connections; miscommunications, failed computer hardware or software or technical failures; garbled, misrouted or scrambled transmissions; incomplete Entries or communications; or other errors; printing, typographical or other errors appearing within these Official Rules, the Website, in any Contest-related advertisements or other materials; or other errors or problems of any kind whether mechanical, human, computer, electronic or otherwise relating to or in connection with the Contest, including, with limitation, errors or problems which may occur in connection with the administration of the Contest, the processing of Entries, the announcement of the prizes, or the cancellation or postponement of any events or games. CHL Entities reserve the right, in their sole discretion, to void any and all Entries of an entrant who CHL Entities believe has attempted to tamper with or impair the administration, security, fairness or proper play of this Contest. PRIZES:

There will be a total of 1 Prizes. The total value of all prizes provided by the Contest is about \$200 CAD. The Prizes consist of one (1) Grand Prize.

The Grand prize consists of one (1) signed Team CHL Jersey from the 2024 Prospects Challenge game.

All prizes must be accepted as awarded and are not transferable or convertible to cash. No substitutions except at CHL Entities' option. CHL Entities reserve the right, in their sole and absolute discretion, to substitute the Prize or a component thereof with a prize of equal or greater value, including, without limitation, but at CHL Entities' sole and absolute discretion, a cash award.

PRIZE DRAW:

A random draw for the 1 prize winners (the "Prize Winners") will take place on Thursday, October 31st, 2024 at 10:00AM ET in Toronto, Ontario from all eligible Entries received during

the Contest Period. An Entry selected will be eligible to win one (1) Prize. The odds of winning a Prize will depend on the total number of eligible Entries received during the Contest Period.

In the event of any error of any kind whatsoever, more potential winners are selected than specified in these Official Rules, the Sponsor reserves the right to hold a random draw amongst all potential prize claimants to award the correct number of prizes.

WINNER NOTIFICATION AND SELECTION:

The selected entrants for the Prizes will be contacted via email by a representative of the CHL Entities by end of day Thursday, October 31st, 2024. If the potential winner cannot be reached OR in the event a potential winner does not accept the prize or fails to comply with these rules and requirements within 24 hours of being contacted by email or phone, the Prize will be forfeited. Upon prize forfeiture, no compensation will be given and the CHL Entities will have sole discretion to randomly select another potential winner.
